We treat your personal data in confidence. We do not disclose the personal data that we gather via our website to third parties for direct marketing purposes of those parties. In addition, we will not disclose the data that you provide to other parties unless you have granted prior consent for this, or unless this is necessary in relation to the execution of the contract or we may or are required to do so, contractually or by law.

DATA PROTECTION
